



**Administrative Information.**

This Qualification Statement is submitted on behalf of Richard N. Campisano, of 34-36 Jones Street, Jersey City, New Jersey 07306, Telephone Number (201) 653-0906 (hereafter referred to as the "Firm"). Richard N. Campisano has been a member of the New Jersey Bar since 1983. Upon admission to the Bar he became partner in the law firm of Bogart, Ryan and Campisano. In December, 1999, Richard N. 


