Council Member Surrago – Environmental Commission resolution to reduce fuel usage. Spoke with Paul and Andy suggested maybe for DPW or OEM positions. Spoke with Lenora and possible for when we look for a new senior bus. Andy and Paul believe if we received 6 to 8% reduction that would be good start. This resolution is night and day from what they originally presented and I think is something that we might be able to do.
