The COVID-19 pandemic has had long lasting effects on the ability of individuals to obtain the food necessary for good nutrition. Some folks have either lost their jobs or their work hours have been significantly reduced. For others, the higher cost of food is making it difficult to make ends meet. There are ways that you can help and ways that you can find the help that you may need.

Glen Rock is sponsoring a special food collection for *Father's Cupboard*, a food pantry located at 21 Harristown Road, Glen Rock (in the back of Grace Redeemer Church). They currently service about 250 families (i.e., 600 individuals) each month. Father's Cupboard is looking for three specific items to supplement the supplies that they receive from foodbanks and other donations.

We still continue to provide meals for those in need. The Gurudwara does not distribute individual meals, but instead has connections with various pantries where we use their distribution network.







#### LEAGUE OF WOMEN VOTERS

The League of Women Voters Provides Information to Voters for our Upcoming Election.

The League of Women Voters of Glen Rock (LWVGR), part of a national, nonpartisan organization (LWVUS) has resources for voters in Glen Rock.

On the Vote411.org website LWVGR will share background information from local candidates for Council and Board of Education positions and provide their responses to questions on topics of interest and importance to Glen Rock voters.

LWVGR can provide important forms to residents for voter registration, change of address, and information sheets about voting procedures.

As it has in the past, LWVGR will host candidates' forums, Candidates' Nights, planned this year for October 18 and 25. Voters will again have the opportunity to listen to the candidates' responses to questions submitted by residents. The League will advertise more information about format (in-person, virtual, hybrid) when the plans are settled with the Borough. The forums will also be broadcast live on GRTV, FIOS Channel 32 and Optimum Channel 77.

Residents may contact LWVGR through email lwvgrnj@gmail to ask questions about voting or membership. Look for members of our local League at voter registration tables at various locations in the borough.

# Bringing Glen Rock History into Your Homes

Do you ever wonder what your house looked like 50 years ago? Has the Rock changed in appearance over the years? When were the schools built and what did they look like? These are just a few of the questions that in the future you can have answered whenever you think about them---just log onto the internet and view the online catalog produced by the Glen Rock Historical and Preservation Society and see the photos that tell our story---free to you and to the rest of the world!

Thanks to two grants received from the Bergen County History Grant Program, the GRHPS will soon begin digitizing and cataloging its enormous collection of photographs and postcards that provide an exciting visual history of the development of our Borough. And, that's just the beginning! Volunteers will also be cataloging and scanning the hundreds of historical artifacts and documents in its collection.

Kathleen Walter, Glen Rock Borough Historian and author of the two Bergen County

History grants, describes these developments as ground-breaking. "The hardware and software
provided by the grants tells just half the story---the other half stems from the many, many hours
our volunteers will be dedicating to this project." She explains that the process is complex and
time-consuming, as each photo must be scanned and fully described before the image and
cataloging data can be uploaded into professional-level collection management software. When a
few hundred photos have been completed, the final step will be to post them on the internet,
where they can be searched and viewed. Walter notes that although the volunteers face a steep
learning curve, they are dedicated to making the project a resounding success and to bringing our
Borough's history to life in the 21 st century!

Kay Tuite, President of the GRHPS, describes this innovative project as a "big lift" for our little museum and handful of volunteers. She smiles and adds that any kind of support is more than welcome---funds for WIFI at the museum, hands for scanning or volunteers for cataloging/describing the photos, artifacts and documents.

#### Need Help with Chores?

Do you need a little help with repairs around the house? Perhaps a leaky faucet or railing that's wobbly? Well, if you're a senior who owns a home in Bergen County, you're in luck. CHORE is a volunteer organization that provides assistance with minor home repairs and other tasks around the house. The volunteers are not licensed electricians or plumbers but have experience with a variety of home repair needs. Ensuring seniors remain safe in their home is CHORE's mission, so volunteers also help with things such as putting in and taking out window air conditioners and changing light bulbs.

There is no charge for the labor provided by CHORE volunteers. Homeowners are responsible for the cost of materials required. Vans carry a variety of supplies which the homeowner may purchase at the time of service. If the needed item is not stocked by CHORE and the homeowner cannot get it themselves, volunteers will arrange to purchase the item, but an additional appointment to complete the task may be needed. When setting up an appointment, ask about needed supplies and how they will be obtained.

One frequent request of CHORE volunteers is the installation of grab bars in the bathroom. CHORE stocks a variety of sizes but volunteers will also install bars purchased by the client. Bathrooms are the most dangerous place in the home and properly installed grab bars greatly reduce the risk of falls.

CHORE is not able to respond to emergency situations and volunteers do not perform outdoor tasks. There is frequently a waiting of several weeks for service. To verify that the service you need is provided, or to schedule an appointment, call CHORE at 201-489-7790 or email them at chore@bergenvolunteers.org.

# SOCIAL SECURITY COST OF LIVING ADJUSTMENTS DURING ONGOING INFLATION

The increasing inflation is causing concern among legislators in Washington. Already there is a new proposal around the halls of Congress to address the effects of inflation and the devastating effect it is having on seniors with fixed incomes. The current plan involves adding \$200 a month per beneficiary to help with rising costs. Although at this time, it is not certain what the final monthly adjustment will be, it appears that some kind of financial relief is in the works. Due to the upcoming midterm elections, however, action is certainly not a given.

The annual Cost of Living Adjustment should be very interesting. Although the trustees have not yet published any updates for 2023, there is every right to believe that the Cost of Living Adjustment could be historical in effect. As soon as we learn what is in the works for 2023 as far as Social Security monthly payments, we will include the final adjustments in our next article.

Finally, some members of Congress are starting to speak to solutions to fix the solvency of Medicare. One of the early ideas being considered is to relax the caps on Medicare payroll taxes so that regardless of your income, you will pay Medicare premiums from payroll deductions with no cap on income. Again, at this time it is just in the discussion phase, but fixing the solvency issue seems to be coming a problem that might get some serious attention in the future.

#### PREDICTING WHAT BENEFICIARIES WILL PAY FOR PRESCRIPTIONS

As someone who actually helps beneficiaries select their Medicare Plans, there is always the concern about what folks are paying for their prescriptions. So here is the issue from someone who actually advises Medicare Beneficiaries when they are selecting their Prescription Plans.

During the Annual Enrollment Period (AEP), we use online Prescription Finders to price out what Prescriptions will actually cost the beneficiary. This period ends on December 7th . At some period of time, AFTER the AEP ends, drug prices change in the formularies by as much as 8%, so that whatever you expected to pay because that is what the plan said they would cost, when you fill your first prescription in the new year, it is not unusual for the that drug's price to be markedly higher than planned.

The problem is that much like a car's sticker price, a drug's list price is the starting point for negotiating discounts, between insurers and drug manufacturers. If at the end of negotiations the list price for a particular prescription goes up, in many cases the beneficiary will pay more than projected. The downside to this is that in many cases, the higher prices will cause a beneficiary to not pay for needed prescriptions because they just cannot afford the higher price. A possible solution would be to streamline access to a Medicare Savings Program. The problem with that is the program is income based, so this program would be available to beneficiaries with low incomes, but in a county like Bergen, many folks would not be able to meet the low income requirement. When negotiating plans to be sold to beneficiaries, CMS approves only the cost sharing amount or Tier a drug will be applied to. Some plans have as many as 6 Tiers. The only real solutions for beneficiaries who are caught in this situation is to appeal the pay-

The only real solutions for beneficiaries who are caught in this situation is to appeal the payment to the insurance carrier. I have many times helped beneficiaries appeal these decisions made by the plans I provide. Sometimes we are successful, sometimes not.

If you are a senior who smokes, chances are you have tried to quit smoking in the past. Most smokers try to quit smoking seven times before they are successful. It is never too late to get benefits from giving up cigarettes. Stopping is likely to expand your life span, help you breathe easier, improve your circulation, increase your senses of smell and taste, and save you money. In addition to the many respiratory illnesses smoking causes and exacerbates, smoking harms your heart, bones, eyes, aggravates diabetes, and increases your chances of getting several types of cancer. It also causes wrinkling of the skin and may cause erectile dysfunction.

Secondhand smoke harms your family and friends. It can cause and/or contribute to their lung and heart problems. Babies younger than one who are exposed to cigarette smoke are more likely to die of Sudden Infant Death Syndrome. Asthma, lung problems, and ear infections are more common among children exposed to secondhand smoke.

Nicotine is addictive. Some people may feel withdrawal symptoms when they try to stop smoking. However, there are many options to help you. It is probably best to start by discussing these with your doctor. Smoke-Free60+ offers mobile apps and text messaging to help you quit. TobaccoFreeNJ offers free phone counseling to help guide you. Nicotine replacement products are available to help you get through withdrawal symptoms. Over the counter products include gums, patches, and lozenges. In some cases, your physician may prescribe medications to reduce withdrawal symptoms.

Many people are under the impression that smoking cigars or pipes is safer than smoking cigarettes. Both involve smoking tobacco. Cigars use tobacco leaves to wrap tobacco, rather than paper, and lack any filters. Pipes contain tobacco in a bowl at the end of a stem to a mouthpiece. They may or may not have filters. Both smoking methods have the same health risks as cigarettes. E-cigarettes are fairly new and not all the risks have been studied. They also use nicotine and are therefore addictive. The aerosols contain carcinogens.
