- Interested parties have one other opportunity for comment at Borough Council meetings, during the public hearing on a given ordinance.

In Recognition of Mental Health Awareness Month 2023

WHEREAS, local resources are available to treat the disease of mental illness, so no one needs to suffer alone or feel hopeless.

NOW THEREFORE BE IT RESOLVED that the Borough of Glen Rock remains a Stigma-Free Zone and recognizes the month of May 2023 as Mental Health Awareness Month.

APPLICATION FOR BERGEN COUNTY OPEN SPACE FUNDING

WHEREAS, the Bergen County Open Space, Recreation, Floodplain Protection, Farmland & Historic Preservation Trust Fund (“County Trust Fund”), provides matching grants to municipal governments and to nonprofit organizations for assistance in the development or redevelopment of outdoor municipal recreation facilities; and

WHEREAS, the Borough of Glen Rock desires to further the public interest by obtaining a matching grant of \$75,000.00 from the County Trust Fund to fund the following project: Wilde Memorial Park Hockey Roller Rink Renovation Project; and

WHEREAS, the governing body/board has reviewed the County Trust Fund Program Statement, and the Trust Fund Municipal Program Park Improvement application and instructions, and desires to make an application for such a matching grant and provide application information and furnish such documents as may be required; and

WHEREAS, as part of the application process, the governing body/board held the required Public Hearing to receive public comments on the proposed park improvements in the application at the beginning of this meeting on May 10, 2023; and

WHEREAS, the County of Bergen shall determine whether the application is complete and in conformance with the scope and intent of the County Trust Fund; and

WHEREAS, the applicant is willing to use the County Trust Fund in accordance with such rules, regulations and applicable statutes, and is willing to enter into an agreement with the County of Bergen for the above-named project and ensure its completion on or about the project contract expiration date.

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Glen Rock:

1. That it is hereby authorized to submit the above completed project application to the County by the deadline of May 12, 2023, as established by the County; and,
2. That, in the event of a County Trust Fund award that may be less than the grant amount requested above, the Borough of Glen Rock has, or will secure, the balance of funding necessary to complete the project, or modify the project as necessary; and,
3. That the Borough of Glen Rock is committed to providing a dollar-for-dollar cash match for the project; and,

4. That only those park improvements identified and approved in the project application, its Trust Fund contract, or other documentation will be considered eligible for reimbursement.
5. That the Borough of Glen Rock agrees to comply with all applicable federal, state, and local laws, rules, and regulations in its performance of the project; and
6. That this resolution shall take effect immediately.

BOROUGH OF GLEN ROCK
COUNTY OF BERGEN

AN ORDINANCE AMENDING THE DRIVEWAY ENTRANCE STANDARDS FOR RESIDENTIAL ZONES TO REQUIRE A 10 FOOT SEPERATION BETWEEN DRIVEWAYS.

WHEREAS, the Borough of Glen Rock (Borough) Council finds it in the best interest of the Borough to amend the driveway separation standards in residential zones to permit residential driveways along a street in the Borough; and

WHEREAS, the separation between driveways is deemed appropriate to safeguard proper sight distances and safe and efficient circulation of adjacent properties; and

NOW, THEREFORE, BE IT ORDAINED by the Borough Council of the Borough of Glen Rock, County of Bergen, and State of New Jersey that Article III, Chapter 188 Section 188-26 “Regulations and specifications” of the “1978 Zoning Ordinance” of the Borough of Glen Rock is and shall be amended in the following particulars only which shall read as follows:

Section 1. Section 188-26 B. (1) shall be and is hereby amended and supplemented in the existing code in the following particulars only: (deleted sections are noted by strikethroughs, new sections are underlined):

- (1.) Residential zones. Concrete for sidewalk shall be not less than four inches in thickness, laid in slabs four feet wide by five feet in length longitudinal with the curbline, with a pitch of 1/4 inch per foot, each 10 feet of length separated from adjoining slabs by a strip of approved bituminous impregnated fiber 1/4 inch by four inches by four feet extending to within 1/4 inch of the finished surface of the sidewalk. Concrete in the sidewalk area of a driveway shall be not less than six inches thick. Driveway entrance slabs or aprons shall be not less than six inches in thickness and separated from sidewalk and curb by an approved bituminous impregnated strip. Driveway apron at the sidewalk line shall not be less than 12 feet wide and not more than 20 feet wide. At the curbline, the apron may exceed the width of the sidewalk line by not more than three feet. In addition, the width of the transition from dropped curb to normal height curb at each side may not be more than 12 inches. No driveway entrance apron shall be constructed within 25 feet of an adjacent street or a corner and 10 feet from an existing or proposed driveway. No exception shall be permitted without the approval of the Zoning Board of Adjustment upon hardship or unusual circumstances being shown.

Section 2. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect.

Section 3. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Borough of Glen Rock, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the Revised General Ordinances of the Borough of Glen Rock are hereby ratified and confirmed, except where inconsistent with the terms hereof.

Section 4. The Borough Clerk is directed to give notice at least ten (10) days prior to a hearing on the adoption of this ordinance to the Bergen County Planning Board and to all other persons entitled thereto pursuant to N.J.S.A. 40:55D-15, and N.J.S.A. 40:55D-63 (if required).

Section 5. After introduction, the Borough Clerk is hereby directed to submit a copy of the within Ordinance to the Planning Board of the Borough of Glen Rock for its review in accordance with N.J.S.A. 40:55D-26 and N.J.S.A. 40:55D-64. The Planning Board is directed to make and transmit to the Borough Council, within 35 days after referral, a report including identification of any provisions in the proposed ordinance which are inconsistent with the master plan and recommendations concerning any inconsistencies and any other matter as the Board deems appropriate.

Section 6. This Ordinance shall be presented to the Mayor for her approval and signature, which approval shall be granted or denied within ten (10) days of receipt of same, pursuant to N.J.S.A. 40:69A-149.7. If the Mayor fails to return this Ordinance with either her approval or objection to same within ten (10) days after it has been presented to her, then this Ordinance shall be deemed approved.

Section 7. This Ordinance shall take effect immediately upon (1) adoption; (2) approval by the Mayor pursuant to N.J.S.A. 40:69A-149.7; (3) publication in accordance with the laws of the State of New Jersey; and (4) filing of the final form of adopted ordinance by the Clerk with (a) the Bergen County Planning Board pursuant to N.J.S.A. 40:55D-16, and (b) the Borough Tax Assessor as required by N.J.S.A. 40:49-2.1.

**ORDINANCE OF THE BOROUGH OF GLEN ROCK, COUNTY OF BERGEN, STATE
OF NEW JERSEY ESTABLISHING A NEW CHAPTER TO BE ENTITLED “OPEN
SPACE, RECREATION, AND FARMLAND AND HISTORIC PRESERVATION TRUST
FUND” OF THE REVISED GENERAL ORDINANCES AS AMENDED**

SECTION 1. Funding; utilization of funds.

- A. The Open Space, Recreation, and Farmland and Historic Preservation Trust Fund shall be funded through the dedication to the fund of an amount of \$0.005 per \$100 of assessed valuation of each annual tax levy commencing with the year 2023 for a period of five years. The fund shall also be permitted to accept donations and testamentary bequests.
- B. The funds accumulated within the trust fund, which began accumulating funds since January 1, 2023, may be utilized for any of the purposes set forth below or any combination thereof without restrictions:
 - (1) The acquisition of properties for recreation and conservation purposes;
 - (2) Development of lands acquired for recreation and conservation purposes;
 - (3) Maintenance of lands acquired for recreation and conservation purposes; and
 - (4) Payment of debt service on indebtedness issued or incurred by the Borough only for any of the purposes set forth in paragraphs (1), (2), and/or (3) above.
- C. Lands acquired by the Borough of Glen Rock using revenue raised pursuant to this tax authorization shall be held in trust and shall be used exclusively for the purposes authorized under N.J.S.A. 40:12-15.1 et seq. The governing body of the Borough of Glen Rock may change the spending allocation for a given calendar year after conducting at least one public hearing thereon.

SECTION 2. All ordinances of the Borough of Glen Rock, which are inconsistent with the provisions of this Ordinance, are hereby repealed to the extent of such inconsistency.

SECTION 3. If any section, sub section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

SECTION 4. This Ordinance shall take effect in accordance with law.

SECTION 5. This Ordinance may be renumbered for codification purposes.

AN ORDINANCE CREATING A PRIDE COMMITTEE WITHIN THE DIVISION OF
COMMUNITY AFFAIRS AND SUPPLEMENTING CHAPTER 4, ARTICLE XII OF THE
BOROUGH CODE OF THE BOROUGH OF GLEN ROCK

WHEREAS, the Mayor and Council of the Borough of Glen Rock wish to create a Pride Committee within the Division of Community Affairs to organize events within the Borough recognizing the contributions of the LGBTQIA+ community, to foster greater understanding, to educate the public, and to celebrate the diverse LGBTQIA+ community,

Now, therefore, be it ordained as follows:

SECTION 1.

Chapter 4, Article XII of the Borough Code of the Borough of Glen Rock is hereby supplemented with the addition of a new section 4-47.2 as follows:

There is hereby established within the Division of Community Affairs a Pride Committee which shall consist of a maximum of 5 and minimum of 2 members appointed by the Mayor with the advice and consent of the Borough Council. The Committee shall organize events within the Borough to recognize the contributions of the LGBTQIA+ community, to foster greater understanding, to educate the public, and to celebrate the diverse LGBTQIA+ community. The Committee shall, from time to time, report to the Mayor and the Borough Council. Members of the Committee shall be residents of the Borough and shall serve for terms of one year or until such later time as their successors are approved and qualified.

SECTION 2.

All other parts, portions and provisions of the Borough Code of the Borough of Glen Rock are hereby ratified and reconfirmed, except where inconsistent with the terms thereof. In the event of any such inconsistency, the terms of this Ordinance shall be deemed to govern.

SECTION 3.

The terms of this Ordinance are hereby declared to be severable; should any part, portion or provision hereof be declared invalid or unconstitutional, said finding shall not affect any other part, portion or provision thereof.

SECTION 4.

This Ordinance shall take effect according to law.

BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY AND NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, IN, BY AND FOR THE BOROUGH OF GLEN ROCK, IN THE COUNTY OF BERGEN, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$735,000 TO PAY THE COST THEREOF, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS.

BE IT ORDAINED by the Borough Council of the Borough of Glen Rock, in the County of Bergen, State of New Jersey, as follows:

Section 1. In the event that bonds are issued pursuant to this ordinance, the aggregate amount of notes hereby authorized to be issued shall be reduced by an amount equal to the principal amount of the bonds so issued. If the aggregate amount of outstanding bonds and notes issued pursuant to this ordinance shall at any time exceed the sum first mentioned in this section, the moneys raised by the issuance of said bonds shall, to not less than the amount of such excess, be applied to the payment of such notes then outstanding.

Section 9. Each bond anticipation note issued pursuant to this ordinance shall be dated on or about the date of its issuance and shall be payable not more than one year from its date, shall bear interest at a rate per annum as may be hereafter determined within the limitations prescribed by law and may be renewed from time to time pursuant to and within limitations prescribed by the Local Bond Law. Each of said bond anticipation

notes shall be signed by the Mayor and by a financial officer and shall be under the seal of said Borough and attested by the Borough Clerk or Deputy Borough Clerk. Said officers are hereby authorized to execute said notes in such form as they may adopt in conformity with law. The power to determine any matters with respect to said notes not determined by this ordinance and also the power to sell said notes, is hereby delegated to the Chief Financial Officer who is hereby authorized to sell said notes either at one time or from time to time in the manner provided by law.

Section 10. It is hereby determined and declared that the average period of usefulness of said purposes, according to their reasonable lives, taking into consideration the respective amounts of bonds or notes authorized for said purposes, is a period of 12.26 years computed from the date of said bonds.

Section 11. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Borough Clerk of said Borough, and that such statement so filed shows that the gross debt of said Borough, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$675,000 and that the issuance of the bonds and notes authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

SECTION 3. The Annual Salaries, weekly wages, and hourly wages shall be paid in bi-weekly installments, except that the Mayor and Council, Secretary of the Board of Health and travel allowance may be compensated quarterly.

SECTION 4. The amount to be paid to each officer or employee within the salary and wage range shall be fixed from time to time by resolution of the Mayor and Council.

SECTION 5. The Mayor and Council may allow a one-time payment of \$500 - \$1,000 for employees who have attended classes and have earned a certification appropriate to their position or department.

SECTION 6. The provisions of any ordinance or ordinances inconsistent with the provisions hereof are hereby expressly repealed.

SECTION 7. Where labor contract prevails, terms and conditions of the contract shall supersede this ordinance.

SECTION 8. This ordinance shall be effective as of January 1, 2023 upon passage and publication as required by law.

AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 162, ARTICLE 1 OF THE BOROUGH CODE OF THE BOROUGH OF GLEN ROCK, "PROPERTY MAINTENANCE – BRUSH, GRASS AND WEEDS"

WHEREAS, the Borough of Glen Rock has determined that it is in the best interests of the health, safety, and welfare of its residents to establish a property maintenance code governing the safe, clean, and orderly maintenance of all lands within the Borough; and

WHEREAS, Chapter 162, Article 1 of the Borough Code sets forth specific provisions with respect to the maintenance of brush, grass and weeds; and

WHEREAS, the Borough of Glen Rock has determined that it is in the best interests of the health, safety, and welfare of its residents to authorize the temporary suspension of all or a part of Chapter 162, Article 1 from time to time in order to address environmental conditions affecting the Borough.

NOW, THEREFORE, be it ordained as follows:

SECTION 1.

Chapter 162, Article 1 of the Borough Code of the Borough of Glen Rock is hereby amended and supplemented with the addition of a new section 162-4.1 as follows:

- A. Findings and determinations. The Borough of Glen Rock hereby finds and determines that it is in the best interest of the health, safety, and welfare of its residents to authorize the temporary suspension of all or a part of Chapter 162, Article 1 from time to time in order to address environmental conditions affecting the Borough.
- B. Definitions. "Environmental conditions" may include, but are not limited to, rain or drought conditions, or seasonal conditions, such as the need for pollinator habitat as they emerge from dormancy.
- C. Temporary Suspension Authorized by Resolution. In order to temporarily suspend all or a part of Chapter 162, Article 1, the Borough shall adopt a resolution setting forth:
 - i. a description of which portions of Chapter 162, Article 1 are to be temporarily suspended;
 - ii. a description of the environmental condition prompting the suspension; and
 - iii. the duration of the suspension, which shall not exceed one calendar month.

SECTION 2.

All other parts, portions and provisions of the Borough Code of the Borough of Glen Rock are

hereby ratified and reconfirmed, except where inconsistent with the terms thereof. In the event of any such inconsistency, the terms of this Ordinance shall be deemed to govern.

SECTION 3.

The terms of this Ordinance are hereby declared to be severable; should any part, portion or provision hereof be declared invalid or unconstitutional, said finding shall not affect any other part, portion or provision thereof.

SECTION 4.

This Ordinance shall take effect according to law.

**AN ORDINANCE TO AMEND CHAPTER 216 OF THE REVISED GENERAL
ORDINANCES OF THE BOROUGH OF GLEN ROCK - 1971 AS AMENDED
ENTITLED "VEHICLES AND TRAFFIC" BEING AN ORDINANCE CONTROLLING
VEHICLE AND TRAFFIC REGULATION WITHIN THE BOROUGH; TO
AUTHORIZE THE INSTALLATION AND PLACEMENT OF TRAFFIC CONTROL
DEVICES ON OR NEAR DESIGNATED MID-BLOCK CROSSWALKS.**

BE IT ORDAINED by the Borough Council of the Borough of Glen Rock, County of Bergen, State of New Jersey, as follows:

Section I - Chapter 216 of the Revised General Ordinances of the Borough of Glen Rock 1971, as amended, being an Ordinance entitled "**Vehicles and Traffic**," is hereby amended as to the following subsection:

- A. Subsection 23 entitled "**Mid-Block Crosswalks**" is hereby amended to add the language that is emphasized in boldface italics below:

The streets or parts of streets described in Schedule XX attached to and made a part of this chapter are hereby designated as mid-block pedestrian crosswalks. The stopping or standing of vehicles within 25 feet of the mid-block crosswalks is prohibited. Appropriate ***traffic control devices, including, but not limited to, signs and*** pavement markers may be installed ***or placed*** on such streets, or parts of streets, consistent with the Manual on Uniform Traffic Control Devices and consistent with the provisions of this chapter.

Section II **VALIDITY-SEVERABILITY** If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be held invalid by a court of competent jurisdiction, such judgment shall not affect or invalidate the remainder of this Ordinance but such judgment shall be confined in its operation to the section, paragraph, subdivision, or clause directly involved in the controversy in which said judgment shall have been

rendered.

Section III All Ordinances or parts of Ordinances inconsistent with the provisions hereof are hereby repealed.

Section IV This Ordinance shall take effect upon passage as required by law.
